2. This is based on the decision communicated by Planning Deptt vide No.PD(P)-12/2008 dated 25.06.2008. All HoDs may incur expenditure under Non-plan against corresponding head of accounts accordingly.

3. All concerned Depts are also advised to submit nominal rolls of the transferred posts within 31st August, 2008 to Finance (Budget) Deptt for release of fund for remaining 5 (five) months from October, 2008 to February, 2009 to determine actual requirement of fund and for taking into the same in RE 2008-09. In case any Deptt fails to provide above information within stipulated date, their claims for further release of fund for remaining 5 (five) months will not be considered.

4. With the transfer of liabilities of salary component from plan to Non-plan sector, THE PLAN OUTLAYS OF ANNUAL STATE PLAN 2008-09 OF ABOVE IDENTIFIED DEPARTMENTS, WHEREVER NECESSARY, SHALL STAND MODIFIED. PLANNING DEPTT SHALL ENSURE THE NEEDFUL IN THIS REGARD.

5. Since Rs.150.00 crores is meant for transferring liabilities for 8 months only, the impact on Non-plan side for the next financial year will be more. Further, since the process of transferring liabilities from Plan to Non-plan side is a continuous process, the additional implication for the next financial year 2009-10, should be accounted for in next year's plan of transferring liabilities. Planning Deptt shall do the needful in this regard.

6. This order shall come in to effect with immediate effect.


