Sub : Change of procedure for drawl of BADP fund.

Sir / Madam

This is to inform you that implementation of the Border Area Development Programme (BADP) w.e.f 2016-17 will be done through online Management Information System (MIS) software prepared by the Ministry of Home Affairs in this regard. Submission of Annual Action Plan (AAP), release of fund, submission of QPRs, UCs, Photographs and monitoring reports by DVMC are to be done online through the MIS.

Accordingly, the procedure followed for implementation of BADP scheme in the State Level till date needs to be modified to cope up with the new system. Following modifications should strictly be followed for drawl of BADP fund while implementation of BADP schemes at the district level.

- a) Necessary administrative approval and expenditure sanction individual project wise is to be obtained from the respective authority through DPO.
- b) The fund is to be sub allocated to the implementing agencies by the district authority immediately after obtaining necessary administrative approval and expenditure sanction of the projects from the competent authority.
- c) Strict compliance of GFR and other financial rules and instructions issued from time to time by FD (Budget) regarding sanctioning / drawl of fund from the State Exchequer is mandatorily be followed while sanctioning of project and drawl of fund under BADP.
- d) The fund under BADP is to be drawn from the State Exchequer directly by the implementing agencies only who implement the scheme at the ground level. Drawl of BADP fund from State Exchequer by any other agency is not permissible.
- e) The drawl of fund should be proportionate to the physical progress of the project & commensurate with the instruction issued by the FD in this regard..
- f) The amount can only be drawn by the implementing agencies in the shape of bankers cheque / demand draft in the name of contractor / farm only after obtaining necessary expenditure sanction from the competent authority in this regard. **No amount can be drawn in cash in any way.**
- g) Non compliance of modification of drawl procedure as mentioned above is viewed seriously and may invite departmental proceedings for the same.

You are therefore, requested to kindly look into the matter and ensure strict compliance of the financial procedure as mentioned above for implementation of BADP schemes at the district level.
